 - ➤ No Trespassing "After hours police will be called & violators will be prosecuted to the full extent of the law"

- The Board approved Sign-In / Sign-Out table to help monitor Clubhouse usage due to over-usage of non-residents, parties without reservations, children underage without parental supervision
 - Owner/Tenant must be present with their guests
 - Friday, Saturday, Sunday have Clubhouse users sign in (primarily during summer) with Name, Unit, # of guests, Time in & time out
 - ➤ Sign-in/sign-out will be every day initially
 - Clubhouse Committee Members needed to help staff the table (WF shirts for committee members)
- o Clubhouse hours for the summer will be 10:00 a.m. to 10:00 p.m.

(Monday through Saturday) and 12:00 p.m. to 10:00 p.m. (Sunday)

- Certain portions of the Clubhouse facilities are weather permitting and also will be closed from time to time for cleaning
- Alcohol
 - Eliminate completely w/in clubhouse boundaries
 - Safety hazard (mixed w/ hot tubs or sauna, broken glass, drunken behavior)
