- 1) Roll and Check-in Procedure was completed.
- 2) <u>Minutes of July 13, 2019 Annual Meeting</u>. Secretary Dottie DeMark read the minutes from the July 13, 2019 Annual Meeting.
- 3) Old Business.
  - a. <u>Update on Parcel Boxes for Packages</u>. Zulema Ryan provided an update on the Board's investigation to date on changing the package pickup away from inside the clubhouse.

- A possible solution is to construct freestanding pedestals in the front area outside of the clubhouse that would each house a number of locked boxes. We would need 84 boxes and the cost to build would be \$11,180.

Linda Barber suggested that it be posted somewhere that alcohol is allowed in the pool area only if it is in a non-glass container. Donna asked for a status on the 3 sprinkler heads near Unit 601 and also advised of 2 trees with low-hanging branches.
